



ASSUMPTION OF RISK AND LIABILITY WAIVER

The adventure _____ takes place in remote areas, where conditions are quite different from our controlled home environments. The forces of nature have their own, often unpredictable, schedule, which makes conditions impossible to control. Inevitably, the challenge of accepting nature and all of its occurrences on her terms rather than ours may be the most wonderful part of any outdoor adventure. In addition, the activities of the adventures in which I am to participate have risks, including risks that cannot be eliminated without impacting the unique character of the adventure.

Baja Adventures led by LEOPOLDO ALEJANDRO SANMIGUEL VELAZQUEZ and REGINA DOMINGO ESGLEAS does not want to reduce your enthusiasm for this adventure, as the enjoyment and challenge of the trip are derived in part from these risks. However, it is important to know in advance what to expect and to be informed of the potential risks, both inherent and otherwise. Even so, the same elements that contribute to the unique character of the activities can cause loss, injury, illness, disability or death. Some, but not all, of the possible risks include:

- Drowning or prolonged exposure to cold, turbulent, obstructed, and/or fast-moving water
- Being struck by or falling against a rock or sharp object.
- Slippery surfaces or exposure to steep rock faces, cliffs, hillsides or mountains.
- Intense cold, heat, sun, snow, rain, fog, and wind leading to hypothermia, dehydration, heat exhaustion or heat stroke.
- Decisions made by leaders / guides, allowing for a variety of perceptions and evaluations subject to errors in judgment.
- Contact with or injuries inflicted by animals, insects, reptiles or plants that may or may not be poisonous.
- Negative reactions from air or water bacteria or viruses.
- Delayed communication or inability to communicate due to remote or foreign settings.
- Accidents due to alcohol and drug use.
- Prolonged delay in medical assistance or ineffective medical treatment due to remote or foreign settings.
- Transportation or equipment failure; vehicle or transportation collisions and accidents.
- Forces of nature such as rockfall, flash floods, lightning, high waves, and high winds.
- Exposure to animals, diseases and infections not common to Mexico;
- Dangerous road, plane, train, boat, animal or automobile travel.
- Political or civil unrest, riots, demonstrations, thievery or terrorism.
- Other trip members or outdoor visitors who may knowingly or unknowingly jeopardize my safety by their actions or mistakes.
- Outdoor living: sleeping in suites, cabins or on the ground; using portable toilet facilities; eating and preparing meals out-of-doors; using gas-operated stoves and lanterns; walking or participating in any activity after dark; and using camp fires.
- Loading, lifting, and/or carrying heavy equipment and supplies

Furthermore, it is essential for each of us, when outdoors, to take responsibility for our own health and safety rather than expecting someone else to. In addition, we must constantly take personal responsibility for the following:

- The surrounding environment and its specific hazards.
- Changes in the weather and temperature.
- How our personal actions may affect the safety of other group members.
- Hiking, riding horses or mules, kayaking, paddleboarding, Freediving, scuba diving, swimming alone or wandering from the suites, cabins, or camp alone;
- Going barefoot at any time or not wearing the proper shoes or footwear for the activity.
- Our physical and mental limitations and those of other group members.
- Keeping well hydrated by drinking copious amounts of water each day.
- Maintaining our body temperature by wearing appropriate layers of clothing.

By signing this document, I choose to participate in the adventure named above, despite these named risks and other unnamed risks that are inherent in this adventure. I acknowledge that my participation in an adventure with Baja Adventures is based on my execution of this liability waiver. I hereby release and discharge Baja Adventures, led by Leopoldo Alejandro Sanmiguel Velázquez and Regina Domingo Esgleas, from and against all liability arising from my participation in the adventure. Furthermore, I agree that this release shall be legally binding upon me personally, all members of my family, and all minors traveling with me, as well as my and their heirs, successors, assigns, and legal representatives. It is my intention to fully assume all the risks associated with this trip and release Baja Adventures from all liabilities to the maximum extent of the law.

I HEREBY AGREE TO BE RESPONSIBLE FOR MY OWN WELFARE AND PROPERTIES AND ACCEPT ALL RISKS OF DELAY, UNANTICIPATED EVENTS, INCONVENIENCE, ILLNESS, INJURY, EMOTIONAL TRAUMA, OR DEATH.
